

## TERMS & CONDITIONS

By approving these terms & conditions and confirming your order, a binding agreement is entered into. When we have received your order, you will receive an automatic e-mail confirming your order. We reserve the right not to deliver in the event that the stock level was incorrect at the time of receiving the order. Should we be unable to deliver in accordance with the terms in the confirmation of order, we will contact you and give you the opportunity to cancel the order.

## AGE RESTRICTIONS

Parental or guardian consent is required for customers under the age of 18. The name and telephone number of the person giving consent shall be entered in the message box at the checkout.

## PAYMENT

You can pay securely using VISA or MasterCard credit/debit cards.

When paying by card you will be asked for the card number, its period of validity and the CVC code. All information is encrypted using SSL encryption, which prevents unauthorized access to card details. We do not store card numbers after the transaction has been carried out.

## PRICES

Prices do not include delivery charges. We retain the right to adjust incorrect prices. Prices shown on the site are in Euros.

## SHIPPING METHODS

Orders are shipped by Fedex, FedEx orders are fully insured by FedEx. A physical street address and signature upon delivery are required. FedEx do not deliver to post-office boxes. When your order leaves our warehouse you will receive a tracking number via e-mail that can be used to track your order on. Packages can be tracked via [www.fedex.com](http://www.fedex.com).

## DELIVERY TIME AND COSTS

Goods will be dispatched on regular working days, monday to fridays. Please note that the following delivery charges do not include import costs that may be due when the package reaches the country of destination. Delivery times may be a little longer during sales and public holidays.

## RETURNS

Please contact us [info@husbands-paris.com](mailto:info@husbands-paris.com) as soon as possible if you wish to return or exchange a product. Our returns guarantee entitles you to return the product for any reason within 14 days of having received it. You have the right to open the package and check the contents but the product must be return unused. HUSBANDS tag and price label and original packaging shall be returned with the item. Please note that you are responsible for the product until it reaches us. Send the package with the dispatch number so that it can be traced. All return shipping costs are to be paid by the customer.

If you wish to send back the whole or part of the order we will refund the amount you have paid. The amount will be refunded to the card that you used for payment. We will not refund the cost of return-shipping costs.

## CUSTOMS AND IMPORT CHARGES

Any customs or import duties are charged once the parcel reaches its destination country. These charges must be paid by the recipient of the parcel. Unfortunately, we have no control over these charges, and cannot tell you what the cost would be, as customs policies and import duties vary widely from country to country. It might be a good idea to contact your local customs office for current charges before you order, so you are not surprised by charges you were not expecting.
